Eliane T. do Amaral Campello is Associate Professor of American and English Literature at the Fundação Universidade do Rio Grande (FURG) and a Ph.D. candidate in Comparative Literature at the Universidade Federal do Rio Grande do Sul (UFRGS). Her M.A. thesis, "Anne Tyler's fragmentary universe: an allegorical reading of *Celestial Navigation*", appeared in chapter form in SANTOS & MATTI, eds. *Literaturas estrangeiras em foco* (1995).
