Alba Maria Zaluar. Ph.D. in Anthropology, Universidade de São Paulo. She is currently a professor and researcher at the Instituto de Medicina Social and the Social Science Department at the Universidade Estadual do Rio de Janeiro. She is the author of *Um Século de Favela* (Fundação Getúlio Vargas, 1998) and of *Para Não Dizer Que Não Falei de Samba: os enigmas da violência no Brasil*, published in *Historia da Vida Privada no Brasil: contrastes da intimidade contemporânea - Vol. IV* (Companhia das Letras, 1998).

Angela Borba. Historian, parliamentary attaché of the Partido dos Trabalhadores in the state assembly of Rio de Janeiro, activist in the feminist movement since 1976, and member of the Secretaria Nacional de Mulheres of the Partido do Trabalhador, she died on July 15, 1998.

Bíla Sorj. With a Ph.D. in Sociology, she is a professor in the Department of Social Sciences of IFCS at the Universidade Federal do Rio de Janeiro, and co-editor of two anthologies: with Alice de Paiva Abreu, she edited *O Trabalho Invisível: estudos sobre trabalhadoras a domicílio no Brasil* (Ed. Rio Fundo, Rio de Janeiro, 1993) and, with Cristina Bruschini, *Novos Olhares: mulheres e relações de gênero no Brasil* (Fundação Carlos Chagas/Marco Zero, São Paulo, 1994). She has also written several articles on feminism and gender relations in work environments.

Bruna Franchetto. She earned a doctoral degree in Social Anthropology from the Museu Nacional/Universidade Federal do Rio de Janeiro. Since 1976 she has done research on indigenous languages, especially those of the Carib family. She has published articles on anthropology and feminism, verbal arts and indigenous oral history, the morpho-syntax and phonology of *kuikúro*, which is spoken in the Alto Xingu region of Mato Grosso, Brazil.

Céli Regina Jardim Pinto. Professor in the Political Science Department of the Universidade Federal do Rio Grande do Sul. She holds a Ph.D. in Political Science.

Cristina Bruschini. Ph.D. in Sociology from the Universidade de São Paulo, researcher at the Fundação Carlos Chagas, where she studies women's work and coordinates the Concurso de Dotações para Pesquisa sobre Mulheres e Relações de Gênero. She is the author of the book, *Mulher, Casa e Família* (Vértice/FCC, 1990) and of various articles in books and scholarly journals. She has organized a number of anthologies, including *Horizontes Plurais: novos estudos de gênero no Brasil* (Editora 34/FCC, 1998).

Elizabeth Vargas. She studied history and sociology and was formerly technical coordinator of the Conselho Estadual da Condição Feminina de São Paulo. In 1995 she became part of the coordinating committee of the Secretaria de Educação Fundamental of the Ministério de Educação e Cultura and in 1996 assumed the position of executive secretary of the Ministério da Justiça's Comissão de Mortos e Desaparecidos Políticos. She is the coordinator of the Programa Universidade Solidária, of the Conselho da Comunidade Solidária.

Elza Salvatori Berquó. Demographer, member of the Grã-Cruz of the Ordem Nacional do Mérito Científico; she founded the Núcleo de Estudos de População of the Universidade Estadual de Campinas, which she coordinated from 1982-1984, where she currently directs the Programa de Saúde Reprodutiva e Sexualidade. She is president of the Comissão Nacional de População e Desenvolvimento and member of the Associação Brasileira de Estudos Populacionais, the International Union for the Scientific Study of Population, and the Comitê Consultivo do Censo Demográfico do Ano 2000 of the Instituto Brasileiro de Geografia e Estatística. She is the author of a number of monographs, books, and articles, including: *Arranjos Familiares no Brasil: uma visão demográfica*, published in *Historia da Vida Privada no Brasil: contrastes da intimidade contemporânea - Vol. IV* (Companhia das Letras, 1998); *Esterilização e Raça em São Paulo. Equidade e Saúde: contribuições da epidemiologia*

(FIOCRUZ/ABRASCO, 1997); *O Brasil e as Recomendações do Plano de Ação do Cairo. Saúde Reprodutiva na América Latina e no Caribe. Temas e Problemas* (PROLAP/ABEP/NEPO/UNICAMP/Ed. 34, 1998).

Helôisa Buarque de Hollanda. She holds master's and doctoral degrees in Brazilian Literature from the Universidade Federal do Rio de Janeiro, as well as having completed post-doctoral work on cultural criticism at Columbia University in New York. She is a tenured professor at the School of Communication at the Universidade Federal do Rio de Janeiro and has published more than ten books and dozens of articles on culture, art, literature, and cultural politics. She has also worked in cinema, radio, television, and newspapers.

Hildete Pereira de Melo. Born in northeastern Brazil, she has lived in Rio de Janeiro since 1970, is married and the mother of three children. She holds a doctoral degree in Economics and is a professor at the Faculty of Economics at the Universidade Federal Fluminense since 1973. She is a consultant for the United Nations, Food and Agriculture Organization, and IPEA. In Brazil she has published articles and book chapters on gender, the labor market, and economic history. An activist in the women's movement since 1976, she was a member of the Conselho Nacional dos Direitos da Mulher from 1985-89.

Jacqueline Pitanguy. A sociologist, she is the director of Cidadania, Estudo, Pesquisa, Informação e Ação and member of the Conselho Diretor da Comissão de Cidadania e Reprodução. She is also a member of the Conselho Diretor do Instituto para a Educação of UNESCO and is a member of the International Council on Human Rights. She is co-founder and member of the Fórum da Sociedade Civil nas Américas.

Leila de Andrade Linhares Barsted. Attorney; director of the non-governmental organization Cidadania, Estudo, Pesquisa, Informação e Ação; editor of *Revista Estudos Feministas*. She is a member of the of the Instituto de Advogados Brasileiros and also of the Conselho Estadual de Rio de Janeiro. She has published numerous papers on human rights from a gender perspective.

Lena Lavinas. She holds a doctoral degree in Economics from the University of Paris III. Adjunct professor of the Universidade Federal do Rio de Janeiro, she currently works at the Instituto de Pesquisa Econômica Aplicada. The author of a number of books and articles, she was editor of the *Revista Estudos Feministas* from 1992 to 1994 and again in 1996. She does research on regional planning, decentralization, the labor market, and gender.

Luiza M. S. Santos Carvalho. She holds a Ph.D. in Sociology from England's University of Essex and was an associate professor at the Centro de Ciências do Homem of the Universidade Estadual do Norte Fluminense until February, 1998. She is currently a researcher at the Núcleo de Estudos e Pesquisas da Mulher of the Universidade de Brasília.

Maria Aparecida Schumacher. She is one of the coordinators of the Rede de Defesa da Espécie Humana (Rio de Janeiro), and previously held the position of Executive Secretary and Director of Political Coordination of the the Conselho Nacional dos Direitos da Mulher.

Maria das Dores Campos Machado. Professor of the Department of Letters and Social Sciences of the Universidade Federal Rural do Rio de Janeiro. She holds a doctors degree in Social Sciences from the Instituto Universitário de Pesquisa do Rio de Janeiro, and won a fellowship from the MacArthur Foundation Population Program. She is the author of *Carismáticos e Pentecostais: adesão religiosa na esfera familiar*, which in 1995 won a national award for the best doctoral dissertation and was published by Editora Autores Associados/Associação Nacional de Programas de Pós-Graduação nas Ciências Sociais in 1996.

Maria Filomena Gregori. She is professor of anthropology at the Universidade Estadual de Campinas, researcher at the Centro Brasileiro de Análise e Planejamento, and holds a Ph.D. in Anthropology from the Universidade de São Paulo. She is the author of the book, *Cenas e Queixas:*

um estudo sobre relações violentas, mulheres, e feminismo (Paz e Terra/Associação Nacional de Programas de Pós-Graduação nas Ciências Sociais, 1993).

Holding a Ph.D. in Anthropology from the University of California at Berkeley, (1989), she is a tenured professor at the Department of Anthropology at the Universidade Federal do Rio Grande do Sul, coordinates the Núcleo de Pesquisa em Antropologia do Corpo e da Saúde, PPGAS- Universidade Federal do Rio Grande do Sul and is an advising professor at the Graduate Program in PPGAS of the Universidade Federal do Rio Grande do Sul.

Rachel Soihet. A tenured professor of the History Department of the Universidade Federal Fluminense, she is author of *Condição Urbana e Formas de Violência - mulheres pobres e ordem urbana - 1890-1920*. (Forense Universitária, 1989), and *A Subversão pelo Riso: estudos sobre o carnaval carioca da Belle Époque ao tempo de Vargas* (Ed. Fundação Getúlio Vargas, 1998). She has written a number of articles on women's history, including *História, Mulheres, Gênero: contribuições para um debate; Gênero e Ciências Humanas; Desafio as Ciências desde a Perspectiva das Mulheres* (Ed. Rosa dos Tempos, 1997).

Valéria Andrade Souto-Maior. A doctoral student in Letters at the Universidade Federal da Paraíba, her master's thesis, *O Florete e a Máscara: Josephina Alvares de Azevedo, dramaturga do século XIX*, at the Universidade Federal de Santa Catarina in 1995, received the Prêmio Centro Interdisciplinar de Estudos de Gênero from the Universidade Estadual do Rio de Janeiro in 1996. A finalist in the Concurso Nacional de Ensaio - Prêmio Xerox (1997), organized by the Secretaria de Estado da Cultura do Paraná, this paper is soon to be published by the editorial sector of that department. ABOUT SUBMISSIONS

1. *Revista Estudos Feministas* accepts original manuscripts on subjects related to the magazine's editorial interests. Manuscripts may be in the form of articles, reviews, essays, or information for the Calendar of Events section.

2. Publishing decisions are made by members of the Editorial Committee. Manuscripts are subject to editorial changes in structure or content, with the author's consent.

3. Manuscripts should be submitted on IBM-format floppy disk, in a word-processing program compatible with Microsoft Word for Windows, and accompanied by a hard copy.

4. Texts should be left-justified and double-spaced (excluding indented sections).

5. The following formatting conventions should be observed:

- . Simple ('...') quotes for words used in non-conventional ways.
- . Double quotes ("...") for quotations.
- . Sparing use of **bold-face type** to emphasize certain terms.
- . Footnotes should be numbered and put at the bottom of the page. References to works cited should be included here, thus eliminating the need for a separate section on references.

6. References should follow the format:

- . FOR BOOKS - Author, title (in italics), place of publication, publishing company, publication date, page number(s).
- . FOR ARTICLES - Author, title, name of periodical (in italics), volume and number, publication date, page number(s).

note: ALL references MUST be included as footnotes.

7. Articles may be as long as 25 lauda (accompanied by abstracts of no more than 10 lines); essays up to 15 lauda; reviews from 4-8 lauda, book notices up to 1 lauda; calendar of events items, no more than 20 lines.

8. Information about the author (position, recent publications) should not exceed 5 lines.
